# Completing DG Documentation Guide

- 1. Is this consignment DG?** (Dangerous Goods)  
If "YES" and meets the criteria go to step 2  
If "NO" Refer to DGLQ (Dangerous Goods in Limited Quantities) Document

*Note: This Document is not permitted for Air Transport.*

- 2. Enter Consignor's Reference**  
This is optional
- 3. Consignor name and full address completed**  
PO Box numbers are not acceptable. Ensure Consignor contact phone number completed
- 4. Consignee (receiver) name and full address completed**  
PO Box numbers are not acceptable

## Dangerous Goods Identification

- 5. Enter the 4 Digit UN Number**
- 6. Enter Proper Shipping Name**  
If the Proper Shipper Name is "N.O.S. (Not Otherwise Specified)" then add Technical Name
